

The Artisan Market opportunities are predominantly located within the main fruit and vegetable produce area (Harvest Hall) but we do have limited locations in Market Square and elsewhere for suitable uses.

The Artisan Market consists of several free-standing, European style timber carts or portable pop-up displays, each of approximately 1.2 metres squared and with a colourful canvas awning to differentiate from other traders.

Small producers of innovative and unique items of food, food products and or ingredients can participate in this opportunity. Artisan arts and crafts will also be considered with similar emphasis on innovation, unique product or design and high quality.

Participating Traders will operate under a casual agreement only. The duration of this agreement could be as short as 2 days, through to a number of months, or as long as mutually agreed.

The Artisan Market trades the same days and times as the Market. This means you must be set up and ready to trade before 9.00am and trade through to 5pm on Tuesday, Thursday, Friday and Saturday, and 3.00pm on Sunday.

The licence fee for a cart commences at \$30 per day for an unpowered site. The schedule of daily fees is as follows (GST will apply in addition to the fee):

^{*}NB – a Saturday or Sunday booking must be made in conjunction with a least 1 weekday <u>prior</u> to the weekend booking. Licence fees will be invoiced and are payable in advance. Fees are correct as at 31 October 2020.

Once a booking is confirmed, Traders requiring one must provide a food licence from Stonnington City Council. To contact the Stonnington City Council go to www.stonnington.vic.gov.au or call 8290 1333.

Prior to arrival on the first day of the booking, all Traders must provide to Market Management:

- a copy of any additional licenses or statutory permits required for the operation of the proposed use.
- a Public Liability Certificate of Currency in the name of the Licensee, for an amount of not less than \$10,000,000 and for the proposed use.
- payment of the hire fee in full, whether it has been invoiced at the time, or not.
- Completed and executed Casual License (provided to you by Prahran Market when confirming your booking)

- Any signage you use in conjunction with your presence must be approved in writing by Management in advance.

We receive far more applications for the Artisan Market than we have places and also have existing arrangements that may preclude us from offering you a space

Preference is given to new food concepts and ideas not already present in Prahran Market or our immediate vicinity. Places are given at the absolute discretion of Management and the reasons why some applications are refused will not be entered into.
